Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District.

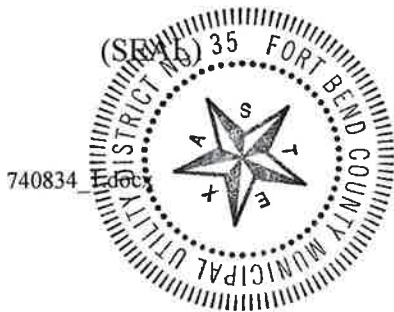
The meeting will be held on Wednesday, September 4, 2024, at 1:00 p.m.

The Board shall consider and/or act on the following matters:

1. Comments from the public;
2. Review and approve the minutes of the August 7, 2024, Board of Directors meeting;
3. Presentation on District for the benefit of Seven Meadows Community Association, Inc. ("Seven Meadows");
4. Proposed Amendment to Maintenance Agreement with Seven Meadows relative to the District's annual contribution toward the maintenance costs for District-owned property;
5. Bookkeeper's Report, including financial investment reports, authorizing the payment of invoices presented;
6. Adoption of operating budget for fiscal year ending September 30, 2025;
7. Engagement of auditor to audit the District's financial statements and prepare the District's audit report for fiscal year ending September 30, 2024;
8. Tax Assessor-Collector Report, including status of delinquent tax accounts, authorizing the payment of invoices presented, approving tax refunds and moving of accounts to uncollectible roll;
9. Conduct a public hearing regarding the adoption of the District's 2024 tax rate;
10. Levy of the District's 2024 debt service and maintenance tax rates, and the adoption of an Order in connection therewith;
11. Approval and execution of an Amended District Information Form;
12. Delinquent Tax Collections Attorney Report, including authorizing foreclosure proceedings, installment agreements and the filing of proofs of claim;
13. Review activity reports and/or receive updates regarding Fort Bend County Precinct 1 Constable's Office;
14. Engineering Report, including:
 - a. Authorizing the design, advertisement for bids and/or award of construction contracts

- or concurrence in the award of a contract for the construction of water, sanitary sewer and drainage facilities within the District and acceptance of Texas Ethics Commission ("TEC") Form 1295;
 - b. Status of construction contracts, including the approval of any pay estimates, change orders and/or acceptance of facilities for operation and maintenance purposes, including:
 - (i) Installation of permanent emergency generator at the District's remote water well (McDonald Municipal and Industrial); and
 - (ii) Little Prong Creek at Gaston Road Slope Repairs (Champions Hydro-Lawn, Inc. ["Champions"]);
 - c. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;
 - d. Approval of lead service line inventory in connection with lead and copper rules for water systems;
 - e. Status of repair of a portion of SOX erosion repair system located at Little Prong Creek by Double Oak Erosion; and
 - f. Status of condition assessment of Wastewater Treatment Plant No. 1;
15. Report by Champions, regarding maintenance of drainage facilities;
16. Status of compliance with the Texas Commission on Environmental Quality Phase II Small MS4 General Permit, including public comments and any training that is necessary under the Storm Water Management Plan;
17. Operations and Maintenance Report, including:
- a. Authorizing the repair and maintenance of District facilities;
 - b. Compliance with Fort Bend County Municipal Utility District No. 34's ("No. 34") water supply and waste discharge permits;
 - c. Appeals of District charges;
 - d. Referral of accounts for collection and deeming of various accounts as uncollectible;
 - e. Report regarding water accountability;
 - f. Status of maintenance of the District's park facilities, including:
 - (i) Discussion regarding use of parking lots for overnight parking and proposed towing policy;
 - (ii) Champions' proposal for maintenance and rehabilitation of landscaping at the District's Dog Park;
 - (iii) Status of replacement of playground mulch at District's Family Park; and
 - (iv) Status of trimming trees overhanging walking paths at District's Family Park;
 - g. Program to reduce the use of flushable wipes within the District;
 - h. Status of replacement of pump controller at Lift Station No. 1;
 - i. Status of repairs in connection with annual fire hydrant survey, including status of painting of District fire hydrants;
 - j. Status of Year 3 of 5 of the District's annual Sanitary Sewer Televising and Cleaning Project;
 - k. Joint Fall Community Event to be conducted in cooperation with No. 34; and
 - l. Status of UCMR-5 testing and the results of same, if applicable;
18. Approval of Letter Agreement with No. 34 relative to 2024 Joint Fall Community Event;

19. District website and mass notification messaging matters;
20. Attorney's Report, including discussion regarding PFAS-related class action litigation and settlements; consider participation in same;
21. Convene in Closed Session pursuant to Open Meetings Act, Section 551.071, Texas Government Code, for consultation with the District's attorney regarding pending or threatened litigation or matters protected by attorney-client privilege;
22. Reconvene in Open Session and authorize any action resulting from discussions in Closed Session; and
23. Matters for possible placement on future agendas.
