AMENDED NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District.

The meeting will be held on Wednesday, March 5, 2025, at 1:00 p.m.

The Board shall consider and/or act on the following matters:

1. Comments from the public;
2. Review and approve the minutes of the February 5, 2025, Board of Directors meeting;
3. Bookkeeper's Report, including financial investment reports, authorizing the payment of invoices presented;
4. Status of continuing disclosure report (due March 30, 2025);
5. Tax Assessor-Collector Report, including status of delinquent tax accounts, authorizing the payment of invoices presented, approving tax refunds and moving of accounts to uncollectible roll;
6. Sales and Use Tax Audit Report from B&A Municipal Tax Service;
7. Delinquent Tax Collections Attorney Report, including authorizing foreclosure proceedings, installment agreements and the filing of proofs of claim;
8. Authorize consultants to research unclaimed property and consider authorizing bookkeeper and tax assessor-collector to prepare Unclaimed Property Report(s) as of March 1, 2025;
9. Review activity reports and/or receive updates regarding Fort Bend County Precinct 1 Constable's Office;
10. Engineering Report, including:
 - a. Authorizing the design, advertisement for bids and/or award of construction contracts or concurrence in the award of a contract for the construction of water, sanitary sewer and drainage facilities within the District and acceptance of TEC Form 1295;
 - b. Status of construction contracts, including the approval of any pay estimates, change orders and/or acceptance of facilities for operation and maintenance purposes;
 - c. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;
 - d. Updated Capital Improvement Plan;
 - e. Status of replacement of sod by Double Oak Erosion; and
 - f. Review exhibit depicting areas of concern located on Little Prong Creek and consider various options to address same;

11. Report by Champions Hydro-Lawn, Inc. ("Champions") regarding maintenance of drainage facilities, including:
 - a. Proposal for repair of damaged drainage pipe;
12. Status of compliance with the Texas Commission on Environmental Quality TPDES Phase II Small MS4 General Permit, including public comments and any training that is necessary under the Storm Water Management Plan ("SWMP");
13. Authorize annual submission to each electric utility that provides transmission and distribution service to the District and each retail electric provider for determination of District facilities that qualify for critical load status relative to compliance with §13.1396, Texas Water Code;
14. Operations and Maintenance Report, including:
 - a. Authorizing the repair and maintenance of District facilities;
 - b. Compliance with Fort Bend County Municipal Utility District No. 34's ("No. 34") water supply and waste discharge permits;
 - c. Appeals of District charges;
 - d. Referral of accounts for collection and deeming of various accounts as uncollectible;
 - e. Report regarding water accountability;
 - f. Status of maintenance of the District's park facilities, including:
 - (i) Proposal for replacement of water fountain at Dog Park; and
 - (ii) Status of mulching trees located at Dog and Family Parks;
 - g. Program to reduce the use of flushable wipes within the District;
 - h. Status of Year 3 of 5 of the District's annual Sanitary Sewer Televising and Cleaning Project;
 - i. Status of communications with Ezee Fiber Texas, LLC regarding damage to District facilities;
 - j. Proposal for services of Certified Playground Safety Inspector; and
 - k. Status of customer refund check;
15. Status of compliance with the EPA's final National Primary Drinking Water Regulation for PFAS;
16. Authorize preparation of Annual Implementation Report regarding Water Conservation Plan and the filing of same with the North Fort Bend Water Authority and the Texas Water Development Board (due May 1, 2025);
17. District website and mass notification messaging matters;
18. Attorney's Report, including:
 - a. PFAS-related class action litigation and settlements; and
 - b. Discussion regarding solid waste collection and disposal service by Best Trash;
19. Convene in Closed Session pursuant to Open Meetings Act, Section 551.071, Texas Government Code, for consultation with the District's attorney regarding pending or threatened litigation or matters protected by attorney-client privilege;
20. Reconvene in Open Session and authorize any action resulting from discussions in Closed Session; and

21. Matters for possible placement on future agendas.
