**NOTICE OF PUBLIC MEETING**

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District. Said meeting will also be conducted via videoconference pursuant to Texas Government Code, Section 551.127, as amended. All members of the public may participate in the meeting in person or via videoconference.

**The meeting will be held on Wednesday, February 4, 2026, at 1:00 p.m.**

The Board shall consider and discuss the following matters and take any action appropriate with respect to said matters:

1. Comments from the public;
2. Review and approve the minutes of meeting held on January 7, 2026;
3. Review and approve audit for fiscal year ended September 30, 2025 (due February 12, 2026); authorize execution of Annual Filing Affidavit;
4. Authorize Disclosure Counsel to prepare and file annual continuing disclosure report in connection with the District's outstanding bonds prior to March 30, 2026;
5. Bookkeeper's Report, including financial investment reports, authorizing the payment of invoices presented, and status of investigation regarding fraudulent transfers from the District's investment account and authorize any actions necessary in connection therewith;
6. Tax Assessor-Collector Report, including status of delinquent tax accounts, authorizing the payment of invoices presented, approving tax refunds and moving of accounts to uncollectible roll;
7. Status of Business List Update for the District's Strategic Partnership Agreement with the City of Houston;
8. Delinquent Tax Collections Attorney Report, including authorizing foreclosure proceedings, installment agreements and the filing of proofs of claim;
9. Review activity reports and/or receive updates regarding Fort Bend County Precinct 1 Constable's Office;
10. Engineering Report, including:
  - a. Authorizing the design, advertisement for bids and/or award of construction contracts

or concurrence in the award of a contract for the construction of water, sanitary sewer and drainage facilities within the District and acceptance of Texas Ethics Commission ("TEC") Form 1295;

26. Reconvene in Open Session and authorize any action resulting from discussions in Closed Session;
27. Matters for possible placement on future agendas.
