NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District. Said meeting will also be conducted via videoconference pursuant to Texas Government Code, Section 551.127, as amended. All members of the public may participate in the meeting in person or via videoconference.

The meeting will be held on Wednesday, August 5, 2026, at 1:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to said matters:

1. Comments from the public;
2. Review and approve the minutes of meeting held on July 1, 2026;
3. Receive the Financial Advisor's recommendation concerning the District's proposed 2026 tax rate, determine intended tax rate, and authorize:
 - a. the required notice that the Board will consider adoption of a tax rate; and
 - b. the means of providing such notice;
4. Bookkeeper's Report, including financial investment reports, authorizing the payment of invoices presented, and status of investigation regarding fraudulent transfers from the District's investment account and authorize any actions necessary in connection therewith;
5. Tax Assessor-Collector Report, including status of delinquent tax accounts, authorizing the payment of invoices presented, approving tax refunds and moving of accounts to uncollectible roll;
6. Delinquent Tax Collections Attorney Report, including authorizing foreclosure proceedings, installment agreements and the filing of proofs of claim;
7. Review activity reports and/or receive updates regarding Fort Bend County Precinct 1 Constable's Office;
8. Engineering Report, including:
 - a. Authorizing the design, advertisement for bids and/or award of construction contracts or concurrence in the award of a contract for the construction of water, sanitary sewer and drainage facilities within the District and acceptance of Texas Ethics Commission ("TEC") Form 1295;

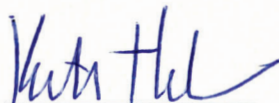
- b. Status of construction contracts, including the approval of any pay estimates, change orders and/or acceptance of facilities for operation and maintenance purposes, including:
 - (i) Wastewater Treatment Plant No. 1 rehabilitation (CROM CFG Industries, LLC);
 - c. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District; and
 - d. Repairs to Little Prong Creek by Grand Lakes Water Control and Improvement District;
9. Status of letter to Avalon at Seven Meadows Homeowners Association ("Avalon"), in connection with Avalon's infrastructure and drainage related concerns of its residents;
10. Report by Champions Hydro-Lawn, Inc. d/b/a Ethoscapes ("Ethoscapes") regarding maintenance of drainage facilities;
11. Consider Letter Agreement for Temporary Fuel Surcharge with Ethoscapes and acceptance of TEC Form 1295 in connection therewith;
12. Report by Ethoscapes regarding maintenance of the District's Family Park and Dog Park, including proposals for various maintenance and repairs of the Parks and parking at the Dog Park;

 - j. Status of communications with Ezee Fiber Texas, LLC regarding damage to District facilities; and
 - k. Proposal for commercial water meter testing;
15. District website and mass notification messaging matters;

16. Review of 5th Year Arbitrage Rebate Calculation Report prepared by Arbitrage Compliance Specialists, Inc. in connection with the District's Unlimited Tax Refunding Bonds, Series 2021;
17. Authorize filing of Local Government Bond, Tax, and Project Database report with Texas Comptroller of Public Accounts pursuant to Section 403.702, Texas Government Code;
18. Status of compliance with annual cybersecurity training as required by Chapters 2054 and 2063, Texas Government Code;
19. Attorney's Report, including:
 - a. PFAS-related class action litigation and settlements; and
 - b. Painting of the decorative light poles in the community by CenterPoint Energy;
20. Convene in Closed Session pursuant to Open Meetings Act, Section 551.071, Texas Government Code, for consultation with the District's attorney regarding pending or threatened litigation or matters protected by attorney-client privilege and Section 551.089, Texas Government Code, regarding deliberation regarding security devises or security audits;
21. Reconvene in Open Session and authorize any action resulting from discussions in Closed Session; and
22. Matters for possible placement on future agendas.
